About the Role

The post holder will be required to take an active role in research focusing on reducing inequalities, third sector resilience and fostering democratic governance and political participation. The research involves four countries (US, UK, Canada and Poland) and in the UK the focus is on Greater Manchester. It employs both quantitative and qualitative methods and uses organisational theories, organisational behaviour theories, sociological theories, and democratic theories, with a focus on adaptive inter-organizational relations, performance, and bureaucratic responsiveness. The post holder will need to have knowledge of good social sciences research techniques including data protection issues and will be experienced in quantitative data collection and analysis. They will be expected to help organise and attend regular project team meetings and help to support project dissemination, for example via maintain a project web page.

Specific duties and responsibilities

The post holder will be expected to:

- a) Engage positively in research activity in the broad area of reducing inequalities, third sector resilience and fostering democratic governance and political participation, using both qualitative and quantitative data collection and analysis under the direction of the project lead/principal investigator and coinvestigator.
- b) Complete high quality research in the area of social policy and associated subject areas, leading on quantitative elements of the project, under the direction of the PI/CI.
- c) Co-author and publish research outputs with the project team in leading peerreviewed journals with an international audience.
- d) Effectively disseminate research findings at internal and external scientific meetings and conferences, making research accessible to lay and expert audiences.
- e) Engage with relevant academic and professional networks through active membership of societies, associations etc.

- f) Contribute to the development of effective applications for research funding from both research councils and other external sources in collaboration with the project lead/principal investigator and others.
- g) Explore opportunities for enterprise activity, knowledge exchange income and/or consultancy in this and related areas.
- h) Contribute to the delivery of teaching at undergraduate and taught postgraduate level.
- i) Assist in the supervision of third year undergraduate dissertation students and taught Masters within the area of research expertise.
- j) Ensure that their skills and technical competence are kept under review and enhanced where required to enable them to utilise specialist equipment and software used in the research projects.
- k) Assist in the development of the research skills of postgraduate students; for example, as part of a postgraduate supervisory team and/or through the delivery of practical workshops.
- l) Contribute to relevant departmental and research group meetings.
- m) Undertake additional duties, as required by the project lead/principal investigator or Head of Department.

In addition to the above, all Edge Hill staff are required to:
